7) Applicant Agreements & Signature:

By submitting this application, the applicant agrees that all information that has been provided is accurate to the best of their knowledge. Applicant understands that due to limited funding and local e-bike supply, a lottery system may be used and not all qualified applicants will receive the instant rebate award. **Applicants must receive an award letter from the Commute Options in order to use the instant rebate.** If applicant is approved for an instant rebate, and purchases an electric bicycle, applicant agrees to:

1. Maintain ownership of the electric bicycle for two years after purchase.
2. Maintain current contact information (ideally email) with Commute Options for the first year after purchase.
3. Agree to use the instant rebate only for its intended use: purchase of an e-bike and accessory safety items (helmet, lock) from a local e-bike retailer.

4. Respond to periodic requests for information from Commute Options staff that ask for information on use of the electric bicycle and comments on the program. (Commute Options will not share your name, however, Commute Options and the City of Bend will use this information to evaluate this program)
5. Adhere to all requirements of the instant rebate
6. **Complete the e-bike safety course on Commute Options' website**

In addition, applicant acknowledges that riding an electric bicycle entails risk, and applicant has been advised to wear and use safety equipment including a helmet and reflective vest and to follow all applicable state requirements.

Applicant shall indemnify, protect, defend, and hold Commute Options and the City, its officers, agents, volunteers, and employees harmless against any actions, claim for injury or damage and all loss, liability, cost or expense, including court costs and attorneys fees, arising out of, or resulting directly or indirectly from, the performance of this program, except, to the extent not prohibited by ORS 30.140, for that resulting from the sole negligence of the City. Nothing in this agreement should be interpreted as imposing any liability on the City beyond the limits of the Oregon Tort Claims Act.
